732 British Orienteering Championships 2009

The report from the appointed Grade 1 Controller, John Warren, identified issues with the proposed Individual day event in the areas of parking, distance to the assembly area, risk of exposure at the assembly area and technical quality for the shorter courses. In his report, JW suggested that we involve experienced officials such as Katy & Dave Stubbs to resolve these issues.

It was recognised that this project is held up pending the resolution of these issues. AF volunteered to be Co-ordinator of the event but JN pointed out that, as a likely major commercial supplier to the event, this would be inappropriate. AF therefore agreed to work on a temporary basis in his capacity as SCOA Chairman to resolve the issues raised in JW's

report. AF will arrange a meeting of the relevant parties, probably at the venue, to investigate the issues and their resolution. *Action: AF*

Clubs are tasked to find candidates for the Event Co-ordinator. *Action: All Clubs*

733 SCOA Championships

The December 2006 Committee meeting discussed the low attendance at SCOA Championships and clubs were asked to consider the options of moving the Championships to a SCOA event or cancelling them permanently. It was decided to move the Championships to a SCOA event from 2008 onwards. The 2007 event is already scheduled for the NWO Regional Event at West Woods on 11 November 2007. It was felt that this event is close enough to the region to attract sufficient numbers.
