907 Minutes of the last Meeting

908 Matters Arising

913 Treasurer's Report

The treasurer's report was distributed at the meeting. Grants have been paid to T Moran, T Morgan and J Blomquist following their selection for England's team to Interland, and D Blomquist for his selection for the World Schools Championships. A grant has been approved for K Stubbs to attend a Level 1 Coaching course but is awaiting the results of a Development Grant application to BOF which may cover some of the cost.

SCOA mileage rate has been raised to 25p in line with the increase in BOF mileage rates.

A costing of SCOA's Coaching Course costs shows a total cost for all clubs of £8,565 in 2011 and £4,455 in 2012. This is based on the estimates provided by clubs to Dave Rogers in November 2010. These levels far exceed the amount of money available for SCOA grants if maintained at a 50% level and probably exceed available funding from the clubs.

915 Junior Squad Manager's Report

Points to note:

- Some members of OUOC are now attending Squad sessions.
- The Squad are planning to raise funds through cake stalls at events.

Fixtures Group are looking at the timings of Junior Events. Squad Managers have made representations, particularly about the timing of the Junior Inter-Regional Championships.

916 Coaching Officer's Report

Six SCOA Coaches attended the recent BOF Coaching Conference.

Ten people have qualified at a recent UKCC Level 1 course.

917 Technical Rep Report

Level C events in SCOA may use 1:10,000 maps. However, survey should be at 1:7,500 so map is still legible at 1:15,000. This is to prevent 'over-mapping'.

The Controller of a Level B event needs to assess the area and write a report on its suitability.

Clubs need to think about the standard they apply to an event and the implications for the requirements. Fixtures Secretaries need to discuss areas and the level of event within their club before they register/publicise the event.

Controllers will now be asked for feedback on events.

Clubs are asked to identify people who could run Event Officials courses. Colin Dickson is running an event safety course in the summer.

KS will look at arranging a Grade 3 Controllers course.

918 Development Officer's Report

LY talked us through the reports from SWOA's February meeting on the presentation by BOF Development Manager, Ed Nicholas. Discussion centred on the Community Orienteering programme and the need for Coaches to run the weekly orienteering activity sessions. The objective is to create 100 Community Clubs at fixed locations over the next three years. The Community Clubs will not necessarily fall within existing club areas.

There is funding available to support the running of the Community Clubs in the first two years although it is expected that participants would be charged a small fee and the meetings would eventually be self-funding. Coaches might cover more than one Community Club location.

919 RDO's Report

No report provided - as explained at the January meeting, the RDO was concentrating on the orienteering section of the Berkshire 'Olympic' competition in schools.

KS proposed a vote of thanks, agreed by all, to Denise Harper for all her work over the last few years as the region's RDO; including promoting links with local schools and councils and assisting clubs with their Clubmark qualification.

920 Any Other Business

- 1. AN advised that the British Schools Championships had secured some sponsorship but still needs more.
- 2. JN had received an email suggesting orienteering get involved in the Nestle Get Set Go Free Promotion. The conditions attached did not seem workable and MF suggested forwarding the email to Caroline Povey at BOF office.
