Technical Officer Report to SCOA Committee Meeting, 20 June 2019

Controllers

No action since the last SCOA meeting. I believe there is still one Level C Controller interested in moving up to Level B. I intend to email all current controllers in the near future to find out their current activities and future plans. We have 4 controllers currently registered with BOF who have not completed the Event Safety workshop:

Tim Booth who is a BKO member but has been living in the USA for quite a few years.

Dave Chapman, who is a SN member but refused to attend a workshop when informed that this would be a requirement. He said he would stop controlling and as far as I am aware he has not done so since. I do not know if he is officiating in any other way at events.

Paul Wallace-Stock, SN, who informed me that he was taking a break from controlling (and other officiating) when I contacted him.

Brian Pilling, SN, who said he would attend a workshop but as far as I am aware has not done so. These members should not continue to remain as licensed controllers. Whilst I am happy to approach Tim, via email, I think it would be better if SN contact their 3 members. They must know better than me if they are active in the sport and should be supported to attend a workshop.
