Current Requirements for appointment to Level B Events - January 2017

See BOF Rules, Appendix C. Note these may change from year to year and you are strongly recommended to check current requirements.

Organisers. Experience **Advised**

Successfully organised a minimum of 2 events at level C or above.

Experience **Required** Completion of an Event Safety and Welfare Workshop.

Planners. Experience **Required**

To have successfully planned or controlled a minimum of 2 events at Level C or above within the last 10 years (one to be within the last 4 years).

Completion of an Event Safety and Welfare Workshop.

Note the following is currently also listed "Attendance at a Regional training course using British Orienteering specified format and materials, with an experienced planner and a controller as course tutors, one of whom is to be course leader."

However the British Orienteering website states that such a course is currently under review and no syllabus or course materials are available. Hence attendance is not a SCOA requirement at this point in time.
